- 6) Each child will answer one question.
- 7) Winner must be able to attend event on Saturday.
- 8) All contestants must be checked in 30 min prior to start time.
- 9) Only 1 adult will be allowed with the child.
- 10) There will be a miss photogenic, 2nd Runner-up 1st Runner-up and a Little Miss Gun Lake. All participants will get a small prize as well.
- 11) Applicant must reside in the Gun Lake area. (Middleville, Orangeville, Martin, Hastings, Delton, or Wayland)
- 12) Entry fee is non-refundable and non-transferable.
