In consideration of participating in the Gun Lake Business Association Gun Lake Winterfest 2020 Bean Bag Tournament, I represent that I understand the nature of the Bean Bag Tournament event and that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I and/or my minor child believe event conditions are unsafe, I and/or my minor child will immediately discontinue participation in the Activity.

I fully understand that the Bean Bag Tournament event involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "RELEASEES" names below; and that there may be other risks either not known to me or not readily foreseeable at this times; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my minor child incur as a result of my and/or my minor child's participation in the Activity.
